



South Dakota's Newest Supreme Court Justice

A welcome is extended to our newest Supreme Court Justice. Justice Severson served as Presiding Judge in the Second Circuit from 2002-2009, and as Circuit Court Judge from 1993-2009.

He has a B.S. and J.D. from the University of South Dakota, and was with Fingerson and Severson from 1983-1992. He was a Huron City Attorney from 1977-1992, a Deputy State's Attorney in 1975, and was with Benson, We-

hde, Martin and Severson, from 1976-1982.



Justice Severson served with the S.D. National Guard from 1967-1973. He is a member of the American Bar As-

sociation, the S.D. Bar Association, and was with the Minnesota Bar Association, Law School Foundation, from 1987-1989.

He has been a member of the S.D. Trial Lawyers Association, and served on the S.D. Board of Water and Natural Resources from 1986-1992. He was a Municipal Attorneys Association

President in 1985, and was President of the S.D. Judges Association from 2001-2002.

Chief Justice's Memo


Spring is a time of transitions.

On Tuesday May 12, 2009, the Groundbreaking Ceremony for the new Hanson County Courthouse in Alexandria was held. Chairman of the Hanson County Commissioners Tom Bell spoke, giving a brief history of the 3 previous Hanson County court-

houses and thanking everyone involved for getting them to this point.

Construction was scheduled to begin May 18th, with a tentative completion date of July 2010.

All Hanson County offices will remain in their temporary locations until then. The Clerk of Courts of-

office is now located at 440 Main Street in Alexandria.

Second Circuit's Courthouse Expansions

Most of the dust has settled and the construction hardhats are back on the shelf in the 2nd Circuit (Lincoln and Minnehaha Counties), where two courthouse construction projects were both completed on time and within budget. The circuit now has a total of 20 courtrooms at three locations (the 20th is a hearing room at the Juvenile Detention Facility in south Sioux Falls).

Beginning in 2007, Lincoln County approved \$8.5 million for a major new county government complex, followed by renovation of the entire 1899 courthouse for use by the Courts only. During the renovation, court was conducted in the county commissioners' chambers, a meeting room in the County Extension Building, and in the basement of Home Federal Bank across the street. We filled a construction dumpster with "stuff" from the courthouse attic alone, and may the dead pigeons and bats rest in peace. The Court is now "back home" with three courtrooms, two judge's chambers, two

jury deliberation rooms, four attorney/client conference rooms, new offices for Court Services and the Clerk's office, a jury assembly room that seats around 50, ample storage space in the basement, and importantly, public bathrooms on every floor.

The new, public law library is still under construction and

there are still some courtroom electronics yet to be installed, but otherwise, the remodeled facility is just about complete. The final electronics installation will include a CourtSmart system that records court in Lincoln County from a control room in Sioux Falls – a first in South Dakota.

Also beginning in late 2007, Minnehaha County appropriated \$11.5 million for a 40,000 square foot expansion of the courthouse in Sioux Falls by adding two floors to the existing courthouse. The expanded courthouse now includes a total of 16 courtrooms on 6 floors, a large meeting/multipurpose room that seats 45, a computer

training center that seats 18, a jury assembly room with a large-screen projection system for 125, additional judges' chambers and court reporter offices, and expanded office space for the Clerk's office and Court Services. The addition also includes a new, dedicated-use prisoner transport elevator directly from the jail for greatly enhanced security – no more sharing one staff elevator with a chain gang on their way to court. The court staff still gets lost on some of the floors and a little finishing work still remains, but we now have the space to accommodate Sioux Falls' rapid growth for years to come. The building is so tall now that we have to have a red flashing light on the roof pursuant to FAA airplane safety requirements – one of the many things you learn about building specs in a big construction project.

The judges and court staff in both counties were in-

Case Management System (CMS) Update

The first vendor evaluation in the process to select a new case management system for UJS has been completed! It was a good learning experience for all involved and we are anxious to move on to the next phase.

As background, after re-

ceiving 15 Letters of Intent from prospective bidders, UJS received nine bid proposals in response to the RFP that was issued in January. All nine proposals were screened according to pre-defined qualification criteria. Five proposals passed the initial screening and were se-

lected for evaluation. Two of those proposals were further found to be deficient, in terms of their ability to meet either our technical or business requirements. The first evaluation was completed by SCAO staff. The Evaluation

Two Graduate From the Institute for Court Management

Two of South Dakota's court professionals became Certified Court Executives and Fellows of the Institute for Court Management (ICM) on Friday, May 15, having successfully completed ICM's flagship Court Executive Development Program. These individuals include:

- Nancy J. Allard, Director of Trial Court Services, State Court Administrator's Office, and
- Beth R. Urban, Human Resources Manager, State Court Administrator's Office.

These two women and 20 other court professionals from across the United States took part in gradua-

tion ceremonies conducted at the Supreme Court in Washington, D.C. Chief Justice of the United States John G. Roberts, Jr. welcomed and addressed the graduates.

The Court Executive Development Program is the only program of its kind in the United States. This professional certification program was established more than 30 years ago, in part, by Chief Justice of the United States Warren E. Burger in his call for improving the management of state court administration. The intensive four-phase educational program better prepares court professionals for management and leadership positions. Since the first class of CEDP graduates in 1970,

more than 1,100 court professionals in 48 states, the District of Columbia, Guam and 12 foreign countries have become Fellows.

process was divided into three sections (1) Company Qualifications (2) Bid Proposal Evaluation and (3) Cost Proposals. Cost proposals were not opened until the first two sections were evaluated and scored.

Vendors selected from the first evaluation will now move on to the next step in the selection process, which is on-site demonstrations to a CMS Evaluation team. This team

consists of Supreme Court Justices, Judges, Circuit Administrators, Clerks of Court, Court Services, and SCAO staff. The second round of evaluations is scheduled for the first two weeks in June and the CMS Evaluation team will make recommendations to the Supreme Court. We will keep everyone updated as we progress toward the selection of a vendor for our new case management system.
