




Chief Justice's Memo

2009 State of the Judiciary Message

Chief Justice David Gilbertson presented the 2009 State of the Judiciary Message on Wednesday, January 14th, on the floor of the House of Representatives.

In the 2009 Message, Chief Justice Gilbertson talked about how times have changed and referred to six major factors facing the System today. He also stated that “the UJS has 545 individuals who are dedicated to getting the job done.” Chief Justice Gilbertson closed his

Message by saying “South Dakota has been known as the ‘Sunshine State.’ Our state flag features ‘the state seal surrounded by a golden blazing sun in a field of sky blue.’ In reality, the sun is not stationary. It rises and sets. To me that sun is rising on South Dakota,

SCAO Attends Rural Courts Seminar

In November, Pat Duggan, Lynn Sudbeck, Janet Borchard and Judith Roberts traveled to Syracuse, New York to attend a Rural Courts Seminar conducted by the Justice Management Institute. Pat also served as faculty at the seminar.

Representatives from six other rural courts across the country also attended: Minnesota, Wisconsin, Utah, Louisiana, New York, and Vermont.

During the course of the 4-day seminar, participants enjoyed networking opportunities and both small and large group discussions regarding providing judicial services and

factors that affect administration of justice in their rural areas.

The seminar included a site visit to an upstate New York problem-solving court and a presentation by several members of the New York federal-state-tribal courts and Indian Nations Justice Forum.

Working together with their colleagues in these other six rural states, the participants found more similarities than differences and heard alternative methods used to resolve similar issues.

Before the seminar was concluded, each state team worked on a plan of their choosing to bring new ideas learned at the seminar back to their state and put them into action. One of the ideas developed by the South Dakota team involved improving relationships between the SCAO and the seven circuits through, inter alia, listening meetings and site visits.

Hanson County Courthouse Fire

The original Hanson County Courthouse was constructed in 1880 in Alexandria and served in that capacity until 1901, when it burned to the ground.

The new courthouse was a two-story brick building of neo-classical design built in 1904 at a cost of \$25,000.

The courthouse was designed by W.R. Parsons and

Son of Des Moines, IA, who also designed the courthouses in Yankton, Turner, and Faulk Counties.

Structural concerns led to the evacuation of the building this past summer. A bond was passed by Hanson County voters during the November election for the construction of a new courthouse.

UJS Case Management System Upgrade in the Works

A Request for Proposal (RFP) to upgrade the UJS trial court and probation case management systems was sent to vendors on January 5, 2009. Vendors must provide notification of intent to bid by February 6, and will have until February 20 to formally respond to the RFP. The SCAO will complete an initial vendor evaluation by mid-

March.

A Case Management System (CMS) Evaluation Team consisting of circuit and SCAO staff has been appointed to evaluate vendor finalists and recommend which vendor should be selected. Vendors selected from the initial evaluation will be invited to present their so-

lution to the CMS Evaluation Team in mid-April. The recommendation from the CMS Evaluation Team will be presented to participants at the May Rural Courts' Retreat.

We will keep everyone updated as we complete the major milestones on this important project!

Thank You for Your Assistance

As some of you know, I have been working towards completing the Court Executive Development Program through the National Center for State Courts. As part of this program, I worked on and completed a research paper on assessing the need and feasibility of an employee assistance program (EAP) for the Unified Judicial System.

I wanted to write this brief update and thank those of you who helped me achieve my goal of completing this paper. For those of you that were not involved in the survey, an EAP is a voluntary and confidential program designed to help identify and facilitate the resolution of behavioral, health, and productivity problems that may adversely affect an employee's well-being and performance.

Typically, these programs are wide-ranging, covering

alcohol and other drug issues; physical and emotional health; and marital, family, financial, legal, and other personal concerns that may affect judges and employees negatively.

Tech-Talk Column

Request for Management Proposal (RMP) Design

The RMP site design is completed and operational for project sponsors to submit proposals that require IT staff resources.

The location has not changed. You can access it directly from Internet Explorer at RMP.SD.GOV or by using the link provided on the UJS website under the *Staff Login, All Staff*, then *IT section*.

The redesign intent was to simplify the application utilizing multiple choice questions with an area for a brief explanation. Another benefit allows IT to provide better tracking and reporting of hours, resources and changes to the original request.

All requests that had not yet been started will need to be resubmitted and will then be rescored using the new scoring mechanism.

If you are unsure if an RMP is needed, send your request to the HELP desk and they will provide feedback whether one is necessary.

Video Conferencing Site Status

The number of Video Conferencing/ITV sites installed by UJS has increased to 41. This includes 29 courtroom installs and 12 sites located in the county jail or detention center. Number 42 – the

Yankton Co. Jail - is on hold, waiting for construction to be completed.

Recent installs include Burke/Gregory County Courthouse, Parker/Turner County Courthouse, Buffalo/Harding Co. Courthouse, Aberdeen/Brown County Jail and an integrated multi-media in Courtroom 5B of the Sioux Falls/Minnehaha County Courthouse.

Additional default options now installed include a monitor cable that allows connecting a tablet or notebook and displaying content locally or as part of a conference, connecting an existing phone line to use microphone and speakers as part of a telephonic conference, and installing an IR receiver to increase the remote control range and sensitivity.
