If the defendant appears as ordered and otherwise obeys and performs the foregoing conditions of this bond, then this bond is declared void. If the defendant fails to obey or perform any of the conditions, payment of this bond shall be due forthwith. Forfeiture of this bond for any breach of its conditions may be declared by any judge or magistrate having cognizance of the above-entitled matter at the time of such breach. If the bond is forfeited and if the forfeiture is not set aside or remitted, judgment may be entered upon motion in such court of this state against each debtor joint and severally for the amount above stated together with interest and costs. Execution may be issued, and payment secured as provided by the South Dakota Code of Criminal Procedure and other laws of the State of South Dakota.

It is agreed and understood that this is a continuance bond (including any proceedings on appeal or review) which shall continue in full force and effect until such a time as the undersigned is duly exonerated.
