For other traffic offenses not covered by municipal ordinance, the fines are the same as the state schedule. For violation of City of Sioux Falls municipal ordinances that do not have a similar or corresponding state statute, the total amount clerk magistrates are directed to charge is \$95, inclusive of fines, fees and surcharges (except for Sioux Falls curfew violations which are assessed a different amount).

Any officer has the authority to require a violator to appear before a magistrate judge.
