

**INSTRUCTIONS AND FORMS FOR NOTICE AND ADMISSION OF SERVICE OF VERIFIED
PETITION FOR NAME CHANGE OF A MINOR CHILD**

This form references specific South Dakota Codified Laws (SDCL), and you can find these laws on the South Dakota Legislature website. If you have any legal questions, it is highly recommended that you consult with an attorney. Court staff are unable to provide you with legal advice or assist you in completing this form. Option 1 – Mailing the Verified Petition to the non-petitioning parent *(The non-petitioning parent will need to sign the admission of service within twenty days of mailing and provide the signed form back to you or file with the Clerk of Court themselves.)*

1. Complete the Notice & Admission of Service Notice and Admission of Service of Verified Petition for Name Change of a Minor Child (Uncontested) (UJS-032A)
 - a) Fill in the caption with the name of the county you are filing in, the judicial circuit number, the name of the minor child as it appears on the birth certificate, the proposed name change, and the case number.
 - b) Fill in the remainder of the form by filling in the name of the non-petitioning parent you are mailing to, the date you are mailing the notice, and the mailing address you are sending to.
2. Complete only the caption of the Admission of Service of Verified Petition for Name Change of a Minor Child (Uncontested) (UJS-032B). The remainder of this form will be completed by the non-petitioning parent.
3. Attach two copies of the Notice & Admission of Service, a copy of the Verified Petition for Minor Name Change (UJS-032A), Admission of Service of Verified Petition for Name Change of a Minor (UJS-032B), Notice of Hearing (UJS-031) Consent (UJS-033) and a return envelope, postage prepaid addressed to yourself and mail to the non-petitioning parent.
4. Complete the Statement of Service (UJS-036) by filling in the caption with the minor child's current name as it appears on the birth certificate, the name you are proposing it be changed to and mark all documents you are mailing to the non-petitioning parent. The Statement of Service (UJS-036) will then need to be filed with the Clerk of Court.

Option 2 – Hand Delivery to the non-petitioning parent *(If you believe the non-petitioning parent will willfully consent to the Petition for Minor Name Change.)*

1. Complete the Admission of Service of Verified Petition for Name Change of a Minor Child (UJS-032B) by filling in only the caption. Leave the remainder of the form blank for the non-petitioning parent to complete.
2. To the Admission of Service (UJS-032B), attach a copy of the Verified Petition for Name Change of Minor Child (UJS-030), the Notice of Hearing (UJS-031), and Consent (UJS-033) and hand deliver to the non-petitioning parent.
3. The non-petitioning parent will need to sign the Admission of Service (UJS-032B) and provide the original back to you, and you will then need to file with the Clerk of Court.

Option 3 – Sheriff or process server – If the non-petitioning parent will not accept service by mail or hand delivery, you may contact the sheriff or process server, to serve the non-petitioning parent. You will be provided with proof of service which will need to be filed with the clerk of court.

You must complete the Admission of Service portion of this form and return the original to the sender within 20 days. In completing the form, you must fill in the town and state where you received the papers and sign and date the document. Failure to sign and return the original Admission of Service within 20 days after the date of mailing without good cause will result in the Court ordering the person so served to pay the costs of personal service. SDCL 15-6-4(i).

After you complete and return this form, you may then answer (respond to) the verified petition within 30 more days. If you choose not to answer in time, an Order for Name Change of a Minor Child pursuant to the verified petition may be entered by the court.
