1

Enhancing Access to Justice for Court Users

Enhancing access to justice by eliminating barriers and ensuring all court users can access court programs and services.

GOALS

- 1. Explore resources and technological innovations to promote access to the courts for all court users.
- 2. Improve access to quality legal representation as well as services for self-represented litigants and limited-English proficient individuals.
- 3. Work with internal and external stakeholders to improve physical access to court facilities and services for all court users.

Building Public Trust and Confidence

Building trust and confidence in the courts through transparency, communication, education, and community engagement.

GOALS

- 1. Utilize educational and other opportunities to expand the public and media's understanding of the court's purpose and responsibility.
- 2. Gather feedback from court users to improve court operations and services.
- 3. Promote confidence in the courts by enhancing communication, service, and transparency.

Effective Court Operations and Services

Delivering transparent services responsive to the needs of court users that are based on data-driven decisions to ensure efficient operations.

GOALS

- 1. Develop tools to ensure data is efficiently used when making decisions regarding court operations, system improvements, and court programs.
- 2. Explore existing court programs and pretrial services for potential implementation and expansion.
- 3. Identify and evaluate new opportunities and processes to centralize the operations of the court.

Improving Courthouse Security, Emergency Preparedness, and Personal Safety

Enhancing the safety of all who visit, conduct business, and work in court facilities.

OALS

- 1. Develop and provide resources and training to the Unified Judicial System (UJS) employees to protect their personal safety and security.
- 2. Establish court security committees in collaboration with local stakeholders in each county to promote site assessments and implement security improvements utilizing appropriated funds.
- 3. Collect and review incident data to identify security gaps.
- 4. Seek additional resources to address security vulnerabilities.

Embracing and Enhancing Technology

Leveraging technology and technological innovations to improve court operations and court performance.

OALS

- 1. Embrace technological innovation and modernization to improve operations and enhance access to justice.
- 2. Enhance the case management system to meet the needs of the judiciary, court customers, justice partners, and the public.
- 3. Maintain secure data and information systems to ensure the safety of private and confidential information.
