# STATEMENT OF LEGAL ISSUES

#### ISSUE 1

THE CIRCUIT COURT ERRED IN FAILING TO DETERMINE THAT

DENR HAD A DUTY TO REQUIRE COMPLIANCE WITH ADMINISTRATIVE RULES

WHEN APPROVING PLANS AND SPECIFICATIONS FOR BLSD.

The Circuit Court found DENR did not have a duty to require compliance with Administrative Rules when approving plans and specifications.

# ISSUE 2

THE CIRCUIT COURT ERRED IN FAILING TO DETERMINE THAT

DENR HAD A DUTY TO REQUIRE BLSD TO OBTAIN A CONSTRUCTION PERMIT

TO BE ISSUED BY THE STATE WATER BOARD WHEN APPROVING PLANS AND

SPECIFCATIONS.

The Circuit Court found DENR did not have a duty to require BLSD to obtain a construction permit pursuant to SDCL 34A-2-27.

### ISSUE 3

THE CIRCUIT COURT ERRED IN FAILING TO DETERMINE THAT DENR HAD A DUTY TO COMPLY WITH SDCL 34A-2-29 WHEN APPROVING PLANS AND SPECIFICATIONS OF BLSD.

The Circuit Court found DENR did not have a duty to comply with SDCL 34A-2-29 when approving plans and specifications of BLSD.

## ISSUE 4

THE CIRCUIT COURT ERRED IN FAILING TO DETERMINE THAT

DENR HAD A DUTY TO FOLLOW THE RECOMMENDED DESIGN CRITERIA MANUAL

WHICH HAS BEEN IN USE BY THE DEPARTMENT SINCE MARCH 1991.

The Circuit Court found DENR did not have a duty to comply with its own manual, entitled Recommended Design Criteria Manual, published March 1991, when approving plans and specifications for the BLSD project.
