LEGAL ISSUES ON APPEAL

I. WHETHER THE TRIAL COURT ERRED OVERRULING THE DEFENDANT'S MOTION FOR A JUDGMENT ACQUITTAL WHERE THE STATE'S EVIDENCE LED THE JURY TO SPECULATE WHETHER THE ACTS AS CHARGED EVER OCCURRED IN ANY TIME PERIOD
