The general public has the ability to sign up for text and/or email notifications for Media and Court Closures only. To get to the site you will follow this link: <https://ujnotifications.sd.gov>


The main screen looks like this; from here you can Register for an account or Login any time after you have Registered.

The first time you go to the site, you will need to register; to do this, you have to click the Register link on the left side of the screen and you'll be taken to this screen where you will enter the following:

- Password / Confirm it
