ORDERED that a judgment affirming the Order of the circuit court be entered forthwith.

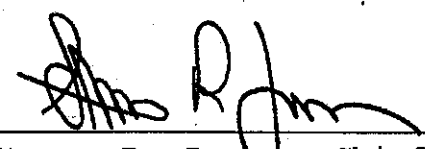
