

JUDICIAL QUALIFICATIONS COMMISSION

The authority for creation of the Judicial Qualifications Commission was granted by The South Dakota Constitution.

The seven-member commission is comprised of two circuit court judges, elected by the judicial conference; three members of the bar practicing law but no more than two of whom may be of the same political party and they must be appointed by a majority vote of the state bar commissioners; and two citizens, who are appointed by the Governor, who are not of the same political party. The term of office for a commission member is four years. No person may serve more than two terms as a member of the commission. The purpose of the Judicial Qualifications Commission is:

- * Receives and investigates complaints against justices or judges
- * Conducts confidential hearings to determine whether complaints are justified
- * Recommends censure, removal or retirement of a judge to the Supreme Court
- * Investigates applicants for vacancies on the Supreme Court or circuit court bench
- * Nominates two or more of the most qualified applicants to the Governor

Chart 2. JQC Complaints Received




Chart 3. JQC Investigations of Applicants


