It is highly encouraged that you speak with an attorney if you are needing assistance. IMPORTANT NOTICE

If a hearing is set on your Motion, the Notice of Hearing must be mailed to the opposing party at least twenty days before the hearing is held.

Complete this form by:

- Complete the caption by filling in the county name, judicial circuit number, Plaintiff and Defendant name, and file number. All of this can be found on any previous filing completed in your case.
 - You can also contact the Clerk of Court, legal help line, or email UJS staff for this information.
- Complete the caption by filling in the line provided with a brief statement of what you are asking the Court to do.
- In the first paragraph you will list in more detail what you are asking the court to do.
- Mark if you are filing an Affidavit in Support of Motion (UJS-337), any supporting attachments/exhibits, and if you are requesting a hearing.
 - These are optional and can be checked if any apply.
- Date and sign in front of a notary or Clerk.
- File the original copy of your Motion, along with any accompanying documents, such as the Affidavit in Support (UJS-337) if you prepared one, and the Notice of Hearing (UJS-336) if you are requesting one, to the Clerk of Court. Remember to retain copies for your records.
- Mail a copy of everything you filed with the Clerk of Court to the opposing party at least twenty days before the hearing.
- Complete an Affidavit of Mailing (UJS-338) and file with the Clerk of Court.
